- 3) Update progress on site goals for 2024-2025
 - a) Mrs. Berumen reviewed our School Plan for Student Achievement (SPSA)
 - b) Key components of the SPSA include our Priority Focus Areas (goals) and related expenditures
 - i) Throughout the year we may revisit expenditures, if/as needs shift during the school year.
 - c) Review of Needs Assessment and Areas of Identified Growth in Literacy, Math, School Climate and SEL/Behavior
 - d) Review of SPSA Goals:
 - i) Goal #1 Sense of Belonging
 - (1) Our school-wide data indicates areas of need in terms of student respect and incidents of racism on our campus. This data is consistent with district-wide data and is a significant area of focus for us in the year ahead.
 - (2) Discussion of our placement in Additional Targeted Support and

Improvement (ATSI) due to chronic absenteeism with our Hispanic student population.

- ii) Goal #2 Social Emotional Learning
 - Information shared regarding the strategies we implement to support student's social emotional learning, including PBIS, Calm Classroom, Zones of Regulation, Restorative Circles, Morning Meetings and Second Step curriculum,
 - (2) Discussion of related expenditures
- iii) Goal #3 Professional Learning Communities/GLAD Training and Implementation
 - (1) Ms. Aguila, Teacher, shared about the work of PLCs at Loma Ridge and how PLC meetings are structured within grade levels. The goal of our PLC work is to examine student data and help to ensure equity in practices within our grade level teams.
 - (2) This year, all teachers are being trained in GLAD strategies as our Professional Learning Plan. Ms. Aguila shared information about how her team is utilizing GLAD strategies in the classroom.
- 4) Review dashboard data & 23-24 annual survey infographic
 - a) Discussion of ratings in the areas of: Chronic Absenteeism, Suspension Rate, English Learner Progress, English Language Arts and Mathematics
 - b) Areas of growth for Loma Ridge include Chronic Absenteeism and English Learner Progress
 - We have an increased focus, both at the school and district level, on support for our English Language Learners (GLAD Training, etc.).
 - c) Mrs. Berumen shared Annual Survey Data Infographic
 - 360 students participated; 100 parents participated we would like to see this number of participants increase
 - ii) Review of areas of concern "38% of students in my school treat each other with respect" and "41% of students have witnessed racism at school" In order to support this area of need, we as a school are putting supports and proactive measures in place for students:
 - (1) Mrs. Berumen and Mrs. Hopkins are visiting with individual classes 4x/yearly to share information about being upstanders and respectful members of the Loma Ridge community. The first presentations began this week.
